PEGGING THE NEW Parliament building as a space that will herald the rise of a developed India and inspire the progress of others, Prime Minister Narendra Modi on Sunday dedicated the new complex to the nation.

The daylong ceremonies to mark the inauguration included a havan, multi-faith prayers and installation of a "Sengol" (sceptre) in the Lok Sabha hall, culminating with the PM's speech, where he reiterated India's position as a global force.

Claiming that "more than just a building, the new Parliament is a symbol of the aspirations and dreams of 1.4 billion people", the PM said this "temple of democracy sends a message of India's unwavering determination to the world".

Modi asserted that India is not only a democratic nation but also the "mother of democracy". "Our democracy is our inspiration, our Constitution our resolve and the Parliament the best representative of this inspiration

India is reaching new heights with a new direction and vision," the PM said, adding that the whole world is watching India with awe and inspiration. "When India progresses, the world also progresses."

He said the new complex will overcome present constraints of space and efficiency with bigger halls and integration with technology, indicating that the number of MPs is likely to increase after 2026, the year when the freeze on the present number ends. The new Lok Sabha hall can seat 888 members against the previous 543 and new Rajya Sabha can seat 384 instead of 250 previously.

The PM also talked of inclusivity and diversity in the new building's décor and design, which is an amalgamation of cultures and crafts of various parts of India. "This building has virasat (heritage) as well as vastu (architecture), kala (art) as well as kaushal (skill), sanskriti (culture) as well as notes of samvidhan (Constitution)," he said.
